

Conditions of participation for the Great Minds Quiz Raffle

KG, Max-Eyth-Straße 1, 74638 Waldenburg, Germany ("Organizer") is conducting a competition among the visitors of page <https://knowhow.distrelec.com/stem/great-minds-great-prizes-challenge-yourself-in-the-quiz/>. The competition is carried out on the basis of the following conditions of participation. The Organizer is responsible for the organization, processing and provision of prizes and distribution of prizes. The prize consists of the [WR-ToolRF Torque Wrench for SMA & RPSMA Plugs](#), [Design Kit WR-SMA Cable Connectors](#) and a [WR-ToolRF Crimping Tool for RF Cable Connector](#) from Würth Elektronik. Any natural person over the age of 18 is eligible to participate. Participants who do not meet all the requirements of the conditions of participation may be excluded from the competition even after the winner has been drawn. The competition starts on 15.05.2023 and ends on 15.07.2023 at 23:59. Participation in the competition is free of charge and independent of the purchase of goods or services. By participating in the competition, the participant accepts these conditions of participation. To participate in the competition, the participant must fill out the email address and the name field. Among all participants who meet the requirements, the winner of the [WR-ToolRF Torque Wrench for SMA & RPSMA Plugs](#) will be determined by the time and how many questions were answered correctly. Lot will determine the winners of the other prizes ([Design Kit WR-SMA Cable Connectors](#) and a [WR-ToolRF Crimping Tool for RF Cable Connector](#)). The winner will be contacted via email by Distrelec within 7 days after the end of the competition. In order to receive the prize the winner must provide a valid shipping address. A cash payment, payment in kind or exchange of the prizes is not possible. The prizes are not transferable. The Organizer reserves the right to terminate the competition prematurely at any time without prior notice and without giving reasons. The Organizer will make use of this possibility in particular if, for technical or legal reasons or due to another incident for which the Organizer is not responsible, a proper execution of the competition cannot be guaranteed. The Organizer will inform the participants about any changes in the competition. Any liability for damages on the part of the Organizer and its bodies, employees and vicarious agents arising from or in connection with the competition, regardless of the legal grounds, shall be limited, to the extent permitted by law, to direct damages verifiably caused by intent or gross negligence. The Organizer is not liable for any damages that occur during the distribution of the prize, the shipment of the prize or during other steps for the implementation of the competition.

Recourse to the courts is excluded.

Data protection

The personal data provided by participants as part of the competition will be collected, stored and used by the Organizer exclusively for the purpose of carrying out and processing the competition and - for example, for the purpose of delivering the prize - passed on to third parties (e.g. to shipping service providers). No further use will take place.

If you participate in one of the Organizer's competitions, the following personal data will be collected by the Organizer:

First and last name, as well as corresponding form of address

Your postal address

Your e-mail address

These data will be used by the Organizer exclusively to determine the winner, to check compliance with the conditions of participation, and to send the prize. The data processing is accordingly based on Art. 6 para. 1 subpara. 1 lit. b DSGVO (processing of personal data for the purpose of fulfilling the contract).

The Organizer will delete the winner's data if it is no longer necessary for the performance of these purposes. This is usually the case when the prize has been sent and the Organizer has made sure that it has reached the winner undamaged.

In the context of the processing of your personal data via the "Distrelec" portal based in the United Kingdom (UK), your data will be transferred to a so-called third country outside of the European Union or outside of the European Economic Area. However, the legality of this cross-border data transfer is based on a so-called adequacy decision pursuant to Article 45 of the GDPR, which is available for the United Kingdom (UK) issued by the European Commission. Such an adequacy decision certifies that the third country has a level of protection equivalent to European data protection law, which means this data transfer does not require special authorization (Art. 45 (1) sentence 2 GDPR).

Of course, each participant has the right at any time to request information about the data stored by the Organizer regarding his or her person in accordance with Art. 15 DSGVO. The same applies to the deletion of the corresponding data at the Organizer according to Art. 17 DSGVO, as well as the correction according to Art. 16 DSGVO and blocking of data according to Art.18 DSGVO.
